

REGULATIONS

on the Youth Wing of the International Union of Non-governmental Organizations «Eurasian Peoples' Assembly»

EURASIAN YOUTH ASSEMBLY

1. General Provisions

- 1.1. These Regulations define the goals and objectives, the order of creation and formation of the program, composition, reorganisation and termination of activities of the Youth Wing of the International Union of NGOs «Eurasian Peoples' Assembly» Eurasian Youth Assembly (hereinafter the Youth Assembly).
- 1.2. The Youth Assembly is established and operates in accordance with the Charter of the Eurasian Peoples' Assembly and on the basis of these Regulations.
- 1.3. The General Assembly, the General Council or the General Council Presidium of the Eurasian Peoples' Assembly approves the Regulations on the Youth Assembly.
- 1.4. Full name of the Youth Assembly in the Russian language: Молодёжное крыло Международного союза неправительственных организаций «Ассамблея народов Евразии» Молодёжная Ассамблея народов Евразии.
- 1.5. Short name of the Assembly in Russian language: Молодёжная Ассамблея народов Евразии.
- 1.6. Short name of the Assembly in English language: Eurasian Youth Assembly.
- 1.7. The Youth Assembly operates on the territory of the Russian Federation, as well as on the territories of other States where members of the Eurasian Peoples' Assembly are registered and work, or where branches or Representative offices of the Eurasian Peoples' Assembly are registered.
- 1.8. The activity of the Youth Assembly is based on the principles of voluntariness, equality of human rights and freedoms regardless of race, gender, language and religion, including in matters of organization management, legality and self-government. The activity of the Youth Assembly is public, and information about it is publicly available.
 - 1.9. The Youth Assembly is not a separate legal entity.
- 1.10. The activities of the Youth Assembly are provided by the Youth Department of the Eurasian Peoples' Assembly.

- 1.11. Members of the Youth Assembly are members of the Eurasian Peoples' Assembly.
- 1.12. Members of the Youth Assembly can be physical persons citizens of the countries of Eurasia, above the age of 18, who share the goals and tasks of the Eurasian Peoples' Assembly, comply with the requirements of the Charter of the Eurasian Peoples' Assembly and participate in the work of the Youth Assembly; the legal entities non-governmental organizations of Eurasian countries, which share the goals and objectives of the Eurasian Peoples' Assembly, comply with the requirements of the Charter of the Eurasian Peoples' Assembly and are directly involved in the work of the Youth Assembly.
- 1.13. The Youth Assembly has a unified corporate style, symbols (emblem, logo, flag), anthem, the provisions of which are approved by the General Council or the General Council Presidium of the Eurasian Peoples' Assembly.
 - 1.14 The official languages of the Youth Assembly are Russian and English.
- 1.15. Address (location) of the permanent governing body of the Youth Assembly: Moscow, Russian Federation.

2. Goals and Subject of Activity

- 2.1. The Youth Assembly is established in order to implement the tasks established in the Charter of the Eurasian Peoples' Assembly and to organize the Eurasian Peoples' Assembly's work with youth.
- 2.2. The main goal of the Youth Assembly is to unite the youth of the Eurasian countries (individuals and legal entities) to represent and protect common interests, achieve socially useful goals in the development of integration processes on the Eurasian continent, form a system of great partnership of the peoples of Eurasia in order to establish peace and harmony in the Eurasian space on the basis of common spiritual and moral principles through public (people's) diplomacy, culture, science, education and entrepreneurship.
- 2.3. The subject of the activities of the Youth Assembly is to perform the following tasks:
- 2.3.1. promotion of new formats of interaction between youth institutions of civil society and members of the Youth Assembly in order to strengthen harmony and peace;
- 2.3.2. facilitating the exchange of experience and information between members of the Youth Assembly on youth policy issues;
- 2.3.3. interaction with international youth organizations and civil society institutions of the Eurasian countries;
- 2.3.4. organization and provision of programs, projects and activities for the development of international youth cooperation, including through national and international grants;

- 2.3.5. promoting scientific research and independent expertise, making proposals to other non-governmental organizations and governments on various aspects of youth social life, participating in the discussion of draft proposals and decisions;
- 2.3.6. providing information, advice and methodological assistance to interested non-governmental organizations in the territory of the Eurasian States on issues that correspond to the main goals of the Youth Assembly;
- 2.3.7. development and distribution of training (educational and informational) materials to support members of the Youth Assembly;
- 2.3.8. facilitating the coordination of publishing, broadcasting and other activities of public relations.

3. Structure of the Eurasian Youth Assembly

- 3.1. The bodies of the Eurasian Youth Assembly are:
- 3.1.2. Coordinating Council a collegial governing body;
- 3.1.3. Chairman of the Coordinating Council;
- 3.1.4. Co-Chairs of the Coordinating Council.

3.2. Coordinating Council

- 3.2.1. The Coordinating Council a collegial governing body of the Youth Assembly.
- 3.2.2. The General Assembly, the General Council or the General Council Presidium of the Eurasian Peoples' Assembly approves the Coordinating Council for a one-year period.
- 3.2.3. Prominent public figures of the Eurasian countries that have been for many years actively engaged in activities that meet the main goals of the Youth Assembly may be elected as members of the Coordinating Council.
- 3.2.4. Powers of the member(s) of the Coordinating Council may be terminated by the General Assembly, the General Council or the General Council Presidium of the Eurasian Peoples' Assembly at the request of the Coordinating Council in the following circumstances: voluntary resignation; termination of membership in the Eurasian Peoples' Assembly; violation of these Regulations, program documents; failure to comply with the decisions of the governing bodies of the Youth Assembly and the Eurasian Peoples' Assembly; other actions (inactions) causing or able to cause damage to the Eurasian Peoples' Assembly.
- 3.2.5. Chairman of the Coordination Council manages the activities of the Coordination Council, and, in his absence the Executive Director or one of the co-Chairs of the Coordinating Council on written instructions from the Chairman of the Coordinating Council.

- 3.2.6. Regular (extraordinary) meetings of the Coordinating Council are convened by the Chairman of the Coordinating Council and held as necessary, but at least once a year. An extraordinary meeting of the Coordinating Council may be convened by the decision of the Chairman of the Coordinating Council, the co-Chairs of the Coordinating Council, or by a written proposal of at least one third of the members of the Coordinating Council.
- 3.2.7. Members of the Coordinating Council must be notified in writing, including using electronic means of communication and the telecommunications networks, including the Internet, of the upcoming meeting of the Coordinating Council no later than 30 (Thirty) days prior to its holding.
- 3.2.8. A meeting of the Coordinating Council of the Youth Assembly is considered competent if at least half of the members of the Coordinating Council are present.
- 3.2.9. Decisions of the Coordinating Council are made by a simple majority of votes from the number of members of the Coordination Council present at the meeting, if there is a quorum. The Coordinating Council determines the form and procedure of voting, including the secret ballot procedure. The Chairman of the Coordinating Council or another person who chaired the meeting of the Coordinating Council, and the Executive Director or another person who acted as Secretary signs the Minutes of the meeting of the Coordinating Council.
 - 3.2.10. The Coordinating Council has the following powers:
- 3.2.10.1. ensures the achievement of the goals and main activities of the Youth Assembly;
- 3.2.10.2. develops drafts of strategic, program and other documents of the Youth Assembly;
- 3.2.10.3. develops recommendations for the implementation of strategic, program documents and regulations of the Youth Assembly;
- 3.2.10.4. interacts within its competence with state authorities, local self-government bodies, political parties, public associations and other organizations;
- 3.2.10.5. establishes and maintains international relations with various non-governmental non-profit organizations and associations;
- 3.2.10.6. establishes specialized Committees for the activities of the Youth Assembly;
- 3.2.10.7. monitors the implementation of long-term projects in the main activities of the Youth Assembly;
- 3.2.10.8. reports on its work to the General Council and the General Council Presidium of the Eurasian Peoples' Assembly;
- 3.2.10.9. makes decisions on other issues of the Youth Assembly's activities.

3.3. Chairman of the Coordinating Council

- 3.3.1. The General Assembly, the General Council or the General Council Presidium of the Eurasian Peoples' Assembly approves the Chairman of the Coordinating Council for a one-year period.
- 3.3.2. The Chairman of the Coordinating Council is an ex officio member of the General Council of the Eurasian Peoples' Assembly.
- 3.3.3. The Chairman of the Coordinating Council has the following powers:
 - 3.3.3.1. provides general management of the Youth Assembly;
- 3.3.3.2. directs and coordinates the activities of the Coordinating Council, the Executive Directorate of the Coordinating Council, convenes regular (extraordinary) meetings of the Coordinating Council and chairs them;
- 3.3.3.3. represents the Youth Assembly in all state and non-state bodies and organizations; is in relations with international state and non-state bodies and organizations, public associations, individuals and legal entities, and mass media;
- 3.3.3.4. approves internal acts regulating, within the legislation of the Russian Federation and these Regulations, the organizational activities of the Youth Assembly in general and of its individual structural units;
 - 3.3.3.5. signs Minutes of meetings of the Coordinating Council;
- 3.3.3.6. controls the response to decisions taken by the Coordinating Council, the Executive Directorate;
- 3.3.3.7. performs other activities that contribute to the effective implementation of the Youth Assembly goals.

3.4. Co-Chairs of the Coordinating Council

- 3.4.1. The Coordinating Council co-Chairs are elected by the Coordinating Council by open vote from among its members and approved by the General Assembly, the General Council or the General Council Presidium of the Eurasian Peoples' Assembly. The members of the Coordinating Council of the Youth Assembly submit candidates. A member of the Coordinating Council of the Youth Assembly may submit his / her candidacy as a self-nomination.
- 3.4.2. The co-Chairs of the Coordinating Council are ex officio members of the General Council of the Eurasian Peoples' Assembly.

Members of the Coordination Council of the Youth Assembly from different countries are elected as co-Chairs of the Coordinating Council.

3.4.3. The co-Chairs of the Coordinating Council have the following powers:

- 3.4.3.1. represent the Youth Assembly in relations with state and non-state bodies and organizations, public associations, individuals and legal entities, and the mass media;
 - 3.4.3.2. chair meetings of the Coordinating Council of the Youth Assembly;
- 3.4.3.3. make statements and appeals on behalf of the Youth Assembly to state and local government bodies, mass media and other organizations;
- 3.4.3.4. make decisions on other issues aimed at achieving the main goals that are not within the exclusive competence of the Chairman of the Coordinating Council of the Youth Assembly.

4. Final provisions

- 4.1. These Regulations enter into force upon the approval by the General Assembly, the General Council or the General Council Presidium of the Eurasian Peoples' Assembly.
- 4.2. Changes in these Regulations are taken by the majority of votes of the members of the General Assembly, the General Council or the General Council Presidium of the Eurasian Peoples' Assembly and formed by the decision of the General Assembly, the General Council or the General Council Presidium of the Eurasian Peoples' Assembly. Decisions to amend the Regulations enter into force on the date of their adoption, unless otherwise decided.
- 4.3. If certain provisions of these Regulations come into conflict with the legislation of the Russian Federation and/or the Charter of the Eurasian Peoples' Assembly, they become invalid and the relevant provisions of the legislation of the Russian Federation and/or the Charter of the Eurasian Peoples' Assembly are applied. The invalidity of certain provisions of these Regulations does not entail the invalidity of other provisions and the Regulations as a whole.
