REGULATIONS

on the International Festival of National Cultures ''Let's Join Hands, Friends''

1. General provisions

- 1.1. The International Festival of National Cultures "Let's Join Hands, Friends" (hereinafter referred to as the Festival) is held as part of the Year of Cultural Heritage of the Peoples of Russia, in pursuance of the state task of the autonomous institution of the Khanty-Mansiysk Autonomous Okrug Ugra "Regional House of Folk Art" for 2022 and the planned period 2023 and 2024 at the expense of the budget of the Khanty-Mansiysk Autonomous Okrug Yugra.
- 1.2. These Regulations regulate the procedure and conditions for holding the Festival.
- 1.3. Founders and organizers of the Festival: Department of Culture of the Khanty-Mansiysk Autonomous Okrug Ugra, Department of Internal Policy of the Khanty-Mansiysk Autonomous Okrug Yugra, autonomous institution of the Khanty-Mansiysk Autonomous Okrug Yugra "Regional House of Folk Art", International Union of Non-Governmental Organizations "Eurasian Peoples' Assembly», Regional branch of the all-Russian public organization "Assembly of the Peoples of Russia" in the Khanty-Mansiysk Autonomous Okrug Yugra.
- 1.4. The festival is held under the support of the Federal State Budgetary Institution of Culture "V.D. Polenov State Russian House of Folk Art».

Goals and objectives of the Festival

- 2.1. The goal of the Festival is to strengthen cooperation between the regions of the Russian Federation, countries, create conditions for intercultural dialogue and interethnic cooperation.
 - 2.2. Festival objectives:
- 2.2.1. Preservation, development and popularization of the traditional culture of peoples.
- 2.2.2. Identification of talented creative teams and individual performers popularizing the culture of ethnic groups.
- 2.2.3. Increasing the performance level of the Festival participants and professional skills of leaders.
- 2.2.4. Improving the mechanisms for the transfer of historical traditions and customs from the older generation to the youth.

5. Evaluation criteria

- 5.1. Nomination "Choreography" the uniqueness and artistic value of the repertoire, stage culture, compositional construction of the performance, performance technique, artistry, compliance with dance folk traditions, regional characteristics, costume range, repertoire compliance with age and technical training of performers;
- 5.2. Nomination "Vocal" the historical and cultural significance of the material presented, the level of performing skills, the correspondence of poetic and musical content, folk costume to national traditions and the age of the performer, the uniqueness and artistic value of the repertoire;
- 5.3. Nomination "Instrumental creativity" uniqueness and artistic value of the repertoire, the level of performing skills, consistency of style, compliance with national traditions;

5.4. Nomination "Ritual, game folklore" - knowledge of the cultural context of the material presented, the ability to recreate the natural forms and lively atmosphere of the ritual and festive action in accordance with national characteristics, the uniqueness and artistic value of the repertoire.

6. Terms of participation in the Festival

- 6.1. The festival is held in two stages, the first qualifying in a remote form. Participants of the Festival provide a video recording of the creative program in accordance with the terms of these Regulations. The second main (full-time) stage is held in the form of a Gala concert with the identification of the winners of the Grand Prix of the Festival.
- 6.2. National amateur creative groups and performers of cultural institutions, national cultural associations, national public organizations can take part in the Festival.
- 6.3. Each creative team, participant performs 2 (two) diverse works with a total duration of not more than 6 minutes.
- 6.4. To participate in the contest, you must fill out an application on the Google platform, this requires a google account. The application is available at the link: https://forms.gle/FBSqNUq8yHHfqdvc8

The contestant fills out an application for participation in electronic form, and attaches competitive works (video recordings), fills out consents to the processing of personal data (Appendix 1 and 2). All files must be signed (the file of the creative work must include the full name / name of the team and the title of the work). Unsigned files will not be accepted.

- 6.5. Contest video recording must meet the following requirements: filming must be performed without turning off and stopping the video camera, from the beginning to the end of the performance of one work, i.e. the work is performed without stopping and editing. Members of the team must be visible on the video.
- 6.6. A video recording with sound overlay, correction of the real sound of the team is rejected from participation in the competitive selection. An amateur video format is allowed, subject to all the conditions of these Regulations of the Festival. It is important that the video is not professionally processed.
- 6.7. The composition of the participants of the Gala concert is formed according to the results of the expert selection of the declared competitive numbers and in accordance with the concept developed by the chief director of the Gala concert.

Official invitations to creative teams and individual performers to participate in the Gala concert are sent by the Regional House of Folk Art from August to September 2022.

6.8. The organizers of the Festival have the right to use video recordings of the performances of the participating teams for educational, methodological, educational and advertising purposes without paying a fee to the performers.

7. Festival Jury

- 7.1. A jury is formed to evaluate the performances of the Festival participants. It includes figures of culture and art of the Russian Federation and abroad, members of the public.
- 7.2. The jury members evaluate the performances of the participants on a 10-point system (a score of up to 10 points is put on the score sheet for each criterion of each nomination, then the points are summed up). The decision to award the participants is entered into the minutes of the meeting of the jury of the Festival and signed by all members of the jury.
- 7.3. The decision of the jury is final and not subject to discussion or revision.

8. Awarding of the Festival participants

- 8.1. Based on the results of competitive viewings, the participants of the Festival can be awarded the following titles: winner of the Grand Prix of the Festival, laureates and diplomats of I, II, III degrees in each nomination and age category.
 - 8.2. The Festival Jury reserves the right to award:
 - additional Grand Prix for participants with a bright creative personality;
 - establish special diplomas and additional nominations;
 - to present not all awards;
 - share awards between several teams and performers;
 - Grand Prix winners are awarded with souvenir products.
 - 8.3. All teams are awarded with a diploma of the participant.
- 8.4. The results of the Festival are posted on the official website and social networks of the Autonomous Institution of the Khanty-Mansiysk Autonomous Okrug Ugra "District House of Folk Art": www.vk.com/odntugra86, www.instagram.com/odntugra86.

9. Financing

Financial expenses for the organization and holding of the Festival are carried out at the expense of the budget of the Khanty-Mansiysk Autonomous Okrug - Yugra.


