

**REGULATIONS**  
**on the International Action**  
**"Day of Spiritual Harmony of the Eurasian Peoples' Assembly"**

**1. General information**

One of the main strategic areas of the Eurasian Peoples' Assembly is the promotion of public and state initiatives aimed at preserving peace throughout the world, establishing the multipolar coexistence of peoples based on the spiritual and moral values of life common to all.

The Charter of the Peoples of Eurasia says: "We affirm the ethical and moral ideals of life and the spiritual foundations of human existence; we respect the right of all peoples to friendship and cooperation. We fully accept as the basis of life the harmony of interhuman relations, which exists on the principles of spiritual harmony of peoples."

Today, in the context of a planetary crisis, accompanied by the instability of life, the establishment of spiritual values capable of uniting people requires constant efforts from both states and public organizations from different countries. The solution of global problems largely depends on the consolidation and cooperation of peoples, on the mutual understanding of people and the ability to conduct a constructive dialogue.

On October 17-19, 1992, Alma-Ata hosted the first Congress of Spiritual Harmony held on the initiative of the International Association "Peace through Culture" and with the support of the First President of Kazakhstan Nursultan Nazarbayev. Its participants - prominent religious and public figures from Austria, Great Britain, Germany, India, Italy, Russia, USA, Switzerland and other countries - proposed to declare October 18, the opening day of the Congress, the Day of World Spiritual Harmony.

The Congress participants called for a moratorium on any military action, clashes, disputes and discussions on this day and dedicate the day to prayers and meditations, calling for harmony, unity, concelebrating in mercy. Provide other forms that promote mutual understanding and spiritual fraternization of the people of the Earth.

The initiative was supported. The Day of Spiritual Harmony is celebrated by public organizations of a number of countries. In the Republic of Kazakhstan it is supported by the State and since 1997 it has become a significant nationwide date. On this day, thematic conferences, round tables, concerts and charity events are held in cities and villages of Kazakhstan. October 18 became a day of mercy, the

establishment of mutual understanding and reconciliation between people of different nationalities and confessions.

The Eurasian Peoples' Assembly, realizing the interdependence of peoples and common responsibility for the future of planet Earth, respecting the moral ideals and cultural values of each nation, supporting the initiative of the Congress of Spiritual Harmony in 1992, as well as the many years of experience in Kazakhstan, proposes to consider the Day of Spiritual Harmony as an important date and annually hold an International Action "Day of Spiritual Harmony of the Eurasian Peoples' Assembly" (hereinafter - the Action) on October 18 in all structural divisions of the Assembly.

## **2. Goals and objectives**

2.1. The Action "Day of Spiritual Harmony of the Eurasian Peoples' Assembly" aims at strengthening international humanitarian cooperation, friendship and mutual understanding of the peoples of Eurasia on the basis of traditional universal values.

2.2. Main goals:

- expansion of interreligious and interfaith dialogue aimed at mutual respect for spiritual beliefs and traditions;
- establishment of spiritual culture as the basis of interhuman relations and international relations;
- search for effective mechanisms for organizing the world community, upbringing and education systems focused on spiritual and moral values and the traditional culture of peoples;
- support of the traditions of charity, mercy and compassion, attention to childhood and orphanhood, old age and loneliness, sick and disabled people.

## **3. Organizers and participants**

3.1. The organizer of the Action is the International Union of Non-Governmental Organizations "Eurasian Peoples' Assembly".

3.2. Members of the Eurasian Peoples' Assembly, partners and friends of the Assembly, public and non-governmental organizations of Eurasian countries, youth organizations. All interested persons are invited to participate in the Action.

## **4. Procedure and conditions of holding**

4.1. Every year on October 18, participants organize and conduct thematic events:

- peacemaking projects aimed at achieving peace and mutual understanding between people and nations;
- conferences, forums, round tables on maintaining interfaith harmony in society, respectful and careful attitude to each other's religious feelings;
- cultural and humanitarian events with the participation of children and youth, aimed at preserving and maintaining traditional values, the memory of ancestors, the connection between generations;
- charitable actions to help those in need, showing care for the younger, sick and infirm;
- other acceptable forms of relations between people and communities, aimed at seeking reconciliation, establishing agreement, showing mercy and helping those close and distant.

4.2. The activities of the Action can be carried out in the long term, during October-month.
